A regular session board meeting of the Pleasant View R-VI School was held on Tuesday, October 10, 2023 in the school cafeteria. Old Business:

A. Discussion was held on school improvements. The new doors for the school are almost complete. This was paid for with the \$50,000 safety grant money. Discussion held regarding draining issues on the east side of the building. A bid has been advertised for work to be done to fix this issue. Lead testing has been completed at the building with 47 locations being tested. Results are pending.

New Business:

- A. Facility Maintenance Plan was discussed with no action.
- B. A motion was made by Jennifer Belvel and seconded by Laurie Frisbie to accept a bid from Zane Jones for a beef market animal. The amount of the bid was for \$1.65/ pound for live weight with the approximate weight of the animal being 1,500 pounds. Motion carried 6-0.

Superintendent's Report:

- A. Basketball games begin next week. Cheerleaders have new skirts thanks to the Pleasant View Community Club.

- B. Pleasant View received \$10,000 for the Grow Your Own grant. This grant is used to help employees and former graduates who are working to become teachers.
- C. Pleasant View did not receive the second round of Safety Grant Money. It was only awarded to the schools that did not receive funding the first round.
- D. Pleasant View was selected to receive the Missouri Quality Preschool Grant. This grant was for 4 year old students. It will cover the cost of tuition for in district four year old students.
