Old Business:

A. Two bids for redoing the flooring in the 3/4/5 were received with no action taken.B. A motion was made by Tim Miller and seconded by Jennifer Belvel to approve the school's CSIP plan. Motion carried 6-0.

C. Discussion was held on health insurance renewal for the 2023-2024 school year with no action taken.

New Business:

A. The oath of office was given to members Damien Little, Benjamin Thomas and Tim Miller. Each of their terms will be for a period of three years.

B. The election of Board officers was as follows:

1. A motion was made by Ben Thomas and seconded by Tim Miller to elect Damien Little as Board President. Motion carried 6-0.

A motion was made by Ben Thomas and seconded by Jennifer Belvel to increase the certified teacher base pay to \$33,500.00 (an increase by \$1,000 to base) and increase the noncertified staff pay by \$.50/hour with all staff being eligible to move up a step in the pay scale for the 2023-2024 school year. F. A motion was made by Jennifer Belvel and seconded by Laurie Frisbie to approve all three levels of Career Ladder for the 2023-2024 school year. Motion carried 6-0.

G. A motion was made by Tim Miller and seconded by Laurie Frisbie to approve a two week summer school for Pleasant View students with tentative dates set for July 10th - 21st. Motion carried 6-0.

H. A motion was made by Jennifer Belvel and seconded by Tim Miller to approve the use of the Immediate Responsive Services Grant for the hire of a one to two day counselor for the 2023-2024 school year. Motion carried 6-0.

I. A board vacancy was declared with applications to be picked up and returned to the school office by May 1st with an appointment being made at the May 9th board meeting.
