Old Business:

- A. All doors have been updated to a new key. There were some water issues with new doors, but they have since been resealed. The school is currently waiting on trim work to be done around the cafeteria door to replace existing walls that are deteriorating.
- B. Results from the initial lead test were reviewed with two locations being retested on Thursday, November 16, 2023. In the meantime signage has been place indicating water is not to be used for drinking.

New Business:

- A. A rough draft of the 2022-2023 audit was reviewed with no action taken.
- B. Bids were opened for the drainage work that is to be done north and east of the building. Tabled for further clarification of the bids.
- C. A motion was made by Jennifer Belvel and seconded by Tim Miller to approve MUSIC as the school's insurance company for the 2024 calendar year for a total cost of

\$29,136.00. This is an increase of approximately 20% due to an increase in claims across the state. Motion carried 6-0.

Superintendent's Report:

A. The Pleasant View R-VI School District will be accepting filings for candidacy for the April 2, 2024 election. Vacancies to be filled are two 3 year terms (Jack Bethards and Jennifer Belvel) and one 1 year term (Derek McCauslin) on the Board of Education. Filing will not occur on days in which the district is closed due to inclement weather or sickness, weekends or between the dates of December 18- December 25, 2023 for winter break. The office will be closed at 1:30 on December 15th. The office will re-open from 4:00 p.m. – 5:00 p.m. only on December 26th.
